

The purpose of this publication is to provide a comprehensive commentary to guide academics, officials, diplomats and others in the implementation of the Treaty.

The book describes what the object and purpose of the Treaty is, what conventional arms, ammunition/munitions and part and components are subject to its provisions, the obligations related to imports, exports, transit, trans-shipment, and brokering, and enforcement measures. The book also details what issues States Parties will need to consider to implement the Treaty's provisions.

The volume provides a systematic analysis of each article of the Treaty drawing on the negotiating history, providing analysis and setting out implementation issues. The authors are academics and experts on the international trade in conventional arms, many with first-hand experience in the negotiations of the Treaty.

Readership: Practitioners and NGO and government legal advisers involved in the interpretation and application of the ATT, and of weapons law in particular, scholars and students of conventional arms control.
