Dear Mr. Danssaert,

This letter is in further reference to your request dated November 20, 2015 for release of information from the Clinton Library under the provisions of Section 3.5 of Executive Order 13526. These Clinton Presidential records were processed in accordance with 44 U.S.C. §§2201-2207 and the Freedom of Information Act, 5 U.S.C. §§552, related to specific (b)(1) closures from 2006-0684-F. We have completed the coordination and processing, according to provisions of E.O. 13526 and FOIA, of the national security classified Presidential records that are responsive to your Mandatory Review request. The following determinations have been made regarding Mandatory Review Case 2016-0165-M.

Documents 1.23, 1.27, 1.35, 1.38, 1.39, 1.50, and 1.66 have been released in full.

Document 1.01 has been released in part. Portions have been exempted from declassification under Sections 1.4(b) and 1.4(c) of E.O. 13526 and 5 U.S.C. §§552(b)(1).

Documents 1.08, 1.11, 1.13, 1.16, 1.18, 1.20, 1.31, 1.37, and 1.42 have been released in part. Portions have been exempted from declassification under Section 1.4(c) of E.O. 13526 and 5 U.S.C. §§552(b)(1).

Document 1.36 has been released in part. Portions have been exempted from release under 5 U.S.C. §§552(b)(6).

Document 1.40 has been released in part. Portions have been exempted from declassification under Section 1.4(c) of E.O. 13526, 5 U.S.C. §§552(b)(1) and 5 U.S.C. §§552(b)(3).

Document 1.43 has been released in part. Portions have been exempted from release under 5 U.S.C. §§552(b)(3).
